

Financial Aid Notes Reminder Regarding Your 1998/99 S.A.R. (Blue Papers) Judi Johnstone, Director of Financial Aid

If you applied for the Cal Grant in February or March, you may

have already received a set of blue papers. These papers constitute your STUDENT AID REPORT for the 1998/99 award year. Your Financial Aid is based on this paperwork starting in July, 1998.

- 1) If you have <u>not</u> completed the 1998/99 F.A.S.F.A., please do so as soon as possible.
- 2) If you don't know what's going on -- please stop by our office as soon as possible.
- 3) Bring your S.A.R. (blue papers) into the Financial Aid Department.

## CAL Grant Update:

You should be receiving possible award information by May 15, 1998. If you receive any information, please bring it into the Financial Aid Office immediately. If you do NOT receive any type of information by May 15, 1998, please call Cal Grant information at (916) 526-7590.

If you have been selected for the CAL Grant C, you will receive a supplement form that needs to be completed and returned to C.S.A.C. This form has a deadline, so please process any form you receive immediately. If you need help filling out the form, stop by the Financial Aid Office.
