 "Unaccompanied" means you are not living in the physical custody of your parent or guardian. "Youth" means you are 21 years of age or younger or you are still enrolled in high school as of the day you sign this application. 			
The financial aid administrator at your college may require you to provide a copy of the determination if you answered " Yes " to any of these questions.
