Free Application for Federal Student Aid (FAFSA)

Beginning January 1, 2017, file the **2017-2018 FREE APPLICATION FOR FEDERAL STUDENT AID (FAFSA)** for Federal Student Aid.

Apply for a FSA ID username and password to electronically sign your FAFSA by going to www.fafsa.ed.gov. A parent must also apply for a FSA ID username and password, if parental information is provided.

You may choose any of these three methods to file a Free Application for Federal Student Aid (FAFSA):

- Apply online at www.fafsa.gov (Recommended and Faster Processing) or
- Complete a PDF FAFSA (Note: PDF FAFSAs must be mailed for processing) or
- Request a paper FAFSA by calling the Federal Student Aid Information Center at 1-800-4-FED-AID (1-800-433-3243) or 1-319-337-5665. If you are hearing impaired, please contact the TTY line at 1-800-730-8913.

Include Humphreys University as one of your school choices to your 2017-2018 FAFSA. School code is **001212**.

CAL GRANT

Attend a *Cal Grant Workshop between January 2017 and February 2017*. The Financial Aid Department will provide you with instructions required to apply for a Cal Grant. (See the Admissions Department for Workshop dates).

The Cal Grant deadline is **March 2, 2017**.

If you miss the Cal Grant deadline you are still required to file the 2017 – 2018 FAFSA for all other Federal Student Aid. This application must be submitted no later than May 1, 2018 to be considered for any type of Financial Aid beginning July 2017 (Summer 2017 Quarter).

Federal Stafford Direct Loans

Once you have received your final disbursement for the current loan period an Award Offer package will be mailed to you to re-apply for Federal Student Loans beginning the following quarter. If you do **NOT** receive your Award Offer package at least one month prior to your new student loan cycle, please contact us immediately.

Acknowledge all correspondence from Humphreys College Financial Aid Department and other financial aid related agencies. We may request additional information or documentation required in determining your financial aid eligibility for the following award year.

Selected for Verification?

Verification is an extensive eligibility review process intended to confirm the information submitted on the FAFSA. If you are selected for verification by the Department of Education or the institution, Financial aid administrators have the right to ask for any [documentation](#) they feel is necessary to complete verification. Federal law states that before awarding Federal Student Aid, we must confirm the information you reported on your FAFSA.
