## Free Application for Federal Student Aid (FAFSA)

Students beginning or returning the following quarter should complete:

### 2022 – 2023 AWARD YEAR

Summer 2022 Qtr (07/2022) : 2022-23 FAFSA  
Fall 2022 Qtr (10/2022) : 2022-23 FAFSA  
Winter 2023 Qtr (01/ 2023) : 2022-23 and 2023-24 FAFSAs  
Spring 2023 Qtr (04/ 2023) : 2022-23 and 2023-24 FAFSAs

### 2023 – 2024 AWARD YEAR

Summer 2023 Qtr (07/2022) : 2023-24 FAFSA  
Fall 2023 Qtr (10/2022) : 2023-24 FAFSA  
Winter 2024 Qtr (01/ 2023) : 2023-24 and 2024-25 FAFSAs  
Spring 2024 Qtr (04/ 2023) : 2023-24 and 2024-25 FAFSAs

Students and parents completing the FAFSA for the first time, must apply for an FSA ID username and password to electronically sign the FAFSA. A parent must also apply for an FSA ID username and password, if parental information is required.

Include Humphreys University as one of your school. **School code is 001212.**

## Cal Grant

Are you wondering if your Cal Grant GPA has been received by the California Student Aid Commission? After you file the FAFSA or CADAA, you can go create an account at [webGrants4students.org](http://webGrants4students.org). This secure site provides information regarding your Cal Grant application by providing access to view the status of your Cal Grant application, update your address, submit corrections, view your payment history, update your college of attendance, or satisfy outstanding requirements.

*Note, the priority deadline for the 2023-2024 FAFSA and GPA Verification form is **Thursday, March 2, 2023**. Undergraduate financial aid applicants completing the 2023-2024 FAFSA must also submit a 2023-2024 GPA Verification form to the Registrar's Office. ## Federal and Institutional Verification

Verification is an extensive eligibility review process intended to confirm the information submitted on the FAFSA. If you are selected for verification by the Department of Education or the institution, Financial aid administrators have the right to ask for **ANY** documentation they feel is necessary to complete verification. Federal law states that before disbursing Federal and State Student Aid, eligibility must be confirmed by confirming FAFSA reported information. Please check for required documents in your financial aid portal.

Upon being accepted to Humphreys University, you will be sent to your Humphreys University email account instructions on how to create an account to the **Humphreys University Student Financial Aid Portal**. You will be able to upload required documents, accept awards, and check the status of your awards at any time.
